ORDER

1. Vide notification read (1) above, University had invited application for Continuation of Provisional Affiliation for the academic year 2025-26. Accordingly, Principals of the following 08 Dental Colleges applied for the same.

2. As per clause II (5) of Ordinance for the conduct of inspection in institutions for granting affiliation, inspection for granting Continuation of Provisional Affiliation will be conducted every year till the first batch of the courses / enhanced seats in that institution is passed out. After that, inspection will generally be conducted once in two years provided the previous year's inspection report is satisfactory without any deficiencies. However, the University may, upon receipt of a serious complaint or on its own volition, decide that there shall be an inspection on any college during any year.

3. The following colleges satisfies the said criteria for granting Continuation of Provisional Affiliation without conducting inspection for the academic year 2025-26, for conducting courses with requested seats mentioned against each:

Vide decision read (2) above, the Governing Council resolved to grant Continuation of Provisional Affiliation to the above said colleges with intake mentioned against each for the academic year 2025-26, without conducting inspection after collecting the fee including GST and the Hon'ble Vice Chancellor has accorded sanction to implement the aforementioned decision of the Governing Council.

5. The above mentioned 08 colleges had remitted the requisite fee for Continuation provisional affiliation including 18% GST.

6. In the circumstances, sanction is hereby accorded to grant Continuation of Provisional Affiliation for the academic year 2025-26 to the above mentioned 08 Dental Colleges for conducting courses with an intake mentioned against each, without conducting inspection.

7. The college shall strictly adhere to the following conditions :-

- Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University / Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- Affiliation granted is strictly provisional and only for the academic year 2025-26. The college has to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the University.
- The College should remit annual administration fee fixed for UG/PG courses for the academic year 2025-26, if applicable.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
