<u>ORDER</u>

- 1. As per notification read (1) above, University had invited application for Continuation of Provisional Affiliation for the academic year 2023–24 from the colleges for the courses affiliated to the university. Accordingly, Principals of the following: Dental Colleges listed below had applied for Continuation of Provisional Affiliation for conducting UC/PG courses in Dental Sciences, with necessary documents and remitted requisite fee
- 2. As per clause II (4) of inspection ordinance, Inspection for granting Continuation of Provisional Affiliation will be conducted every year till the first batch of the courses/enhanced seats in that institution is passed out. After that inspection will generally be conducted ones in two years provided the previous years inspection report is satisfactory without any deficiencies. The following colleges satisfies the criteria for granting Continuation of Provisional Affiliation without conducting inspection for the AY 2023-24.

- 4. Accordingly,orders are hereby Issued granting continuation of Provisional Affiliation to above mentioned 05 Dental colleges for the AY 2023-24, Without conducting inspection.
- 5. The college shall strictly achere to the following conditions:-
- · Selection, admission and collection of fees shall be made only on the basis of the rules and



regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.

Affiliation granted is strictly provisional and only for the academic year 2023–24. The college
has to apply for continuation of provisional affiliation for the ensuing years remitting the fee
fixed by the University.

 The College should remit annual administration fee fixed for UG/PG courses for the academic year
 2023–24.

 Admission to the next academic year shall be made only after obtaining prior permission from the University.
